For resistance management, please note that MANZATE PRO-STICK Fungicide contains a Group M3 fungicide. Any fungal population may contain individuals naturally resistant to MANZATE PRO-STICK Fungicide and other Group M3 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of action but specific for individual chemicals, such as enhanced metabolism, may also exist.
